Invitation to Bid for the

SUPPLY AND DELIVERY OF VARIOUS SIZES OF G.I. FITTINGS (LOT 1), VALVE (LOT 2), AND FLANGE TYPE VALVE (LOT 3)

1. The Metro Iloilo Water District (MIWD) through the Corporate Fund of 2017 intends to apply the sum of **TWO MILLION SEVEN HUNDRED SIXTY ONE THOUSAND TWO HUNDRED PESOS (P 2,761,200.00) FOR LOT 1 - VARIOUS SIZES OF G.I. FITTING, FIVE MILLION TWO HUNDRED TWENTY NINE THOUSAND FIVE HUNDRED PESOS (P 5,229,500.00) FOR LOT 2 - VARIOUS SIZES OF VALVE, and FOUR HUNDRED FIFTY SEVEN THOUSAND EIGHT HUNDRED PESOS (PH P 457,800.00) FOR LOT 3 - VARIOUS SIZES OF FLANGE TYPE VALVE** being the Approved Budget for the Contract (ABC) to payments under the contract for each lot/item. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
2. The MIWD-BAC now invites bids for the **SUPPLY AND DELIVERY OF LOT 1- VARIOUS SIZES OF G.I. FITTING, LOT 2- VARIOUS SIZES OF VALVE, AND LOT 3 - VARIOUS SIZES OF FLANGE TYPE VALVE**. Delivery of the Goods is required within thirty (30) calendar days upon receipt of the Notice to Proceed (NTP). Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project and whose value is equivalent to at least 25% of the ABC to be bid. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from the Office of the Bids and Awards Committee and inspect the Bidding Documents at the address given below during office hours (8:00 a.m. to 5:00 p.m.)
5. A complete set of Bidding Documents may be acquired by interested Bidders on **July 22, 2017** from the address below and upon payment of the applicable non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of: **Lot 1 -Three Thousand Five Hundred Pesos (Ph P 3,500.00); Lot 2 - Six Thousand Pesos (Ph P 6,000.00); and Lot 3 – Five Hundred Pesos (Ph P 500.00)**
6. The MIWD will hold a Pre-Bid Conference on **July 31, 2017; 2:00 P.M.** at the BAC Office, 4th Floor, MIWD Building, Bonifacio Drive, Iloilo City, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before **9:45 A.M. of August 14, 2017**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **August 14, 2017; 10:00 A.M.** at BAC Office, 4th Floor, MIWD Building, Bonifacio Drive, Iloilo City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. Interested bidders may obtain further information from the **BAC Secretariat c/o Mr. Jennis C. Velasco at the MIWD Office, Bonifacio Drive, Iloilo City** from **8:00 A.M. to 4:00 P.M. only, Mondays to Fridays** starting **July 22, 2017 at Tel. No. (033) 337-4744 Local 401**. However, any query relative to the contents of the bidding documents and the project requirements can only be made by bidders who purchased the bid documents **not later than Ten (10) days prior to the Submission and Bid Opening**.
9. The MIWD reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
