Invitation to Bid for the

SUPPLY AND DELIVERY OF TWO (2) UNITS BRAND NEW OFFICE VEHICLES UNDER PR NO. 13799

1. The Metro Iloilo Water District (MIWD) through the Corporate Fund of 2020 intends to apply the sum of **TWO MILLION FIVE HUNDRED THOUSAND PESOS (PHP 2,500,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **SUPPLY AND DELIVERY OF TWO (2) UNITS BRAND NEW OFFICE VEHICLES**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The ***Metro Iloilo Water District*** bids for the **SUPPLY AND DELIVERY OF TWO (2) UNITS BRAND NEW OFFICE VEHICLES** to be delivered within Ninety (90) days upon receipt of the Purchase Order (PO) and/or signing of Notice to Proceed (NTP). Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project and whose **value is equivalent to at least fifty (50%) of the ABC** to be bid. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from the **Office of the Bids and Awards Committee** and inspect the Bidding Documents at the address given below during office hours (8:00 a.m. to 5:00 p.m.).
5. A complete set of Bidding Documents may be purchased by interested Bidders starting **October 01, 2020** from the address below or request a downloadable copy through e-mail, social media, or telephone and upon payment of the applicable nonrefundable fee for the Bidding documents, pursuant to the latest guidelines issued by the GPPB in the amount of **Five Thousand Pesos (P5,000.00)**.


6. The MIWD will hold a **Pre-Bid Conference on October 09, 2020; 2:00 P.M. which will be conducted online (Zoom or Messenger) due to the pandemic** and shall be open to prospective bidders. (Zoom invite can be seen on the next page and for those who prefer in Messenger, please inform the MIWD BAC prior to the scheduled activity.)
7. Bids must be duly received by the BAC secretariat at the address below on or before **9:45 a.m. of October 22, 2020**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause18.

Bid opening shall be on October 22, 2020, 10:00 a.m. at the MIWD Building and Bids will be opened online in the presence of the Bidders or the Bidders' representatives with the use of either Zoom or Messenger. (Invite to be announced)

8. Interested bidders may obtain further information from the **BAC Secretariat c/o Mr. Norman Nicolas C. Sanares at the MIWD Office, Bonifacio Drive, Iloilo City** from **8:00 a.m. to 5:00 p.m. only, Mondays to Fridays starting October 01, 2020 at Tel. No. (033)337-4744 local (316)**. However, any query relative to the contents of the bidding documents and the project requirements can only be made by bidders who purchased the bid documents **not later than Ten (10) days prior to the Submission and Bid Opening**.

The **Metro Iloilo Water District** reserves the right to reject any and all bids, declare a failure of bidding or not award the contract at any time prior to contract award in accordance with Section 41 of R.A. 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
