## **INVITATION TO BID FOR Supply and Delivery of Twenty Eight (28) Units of Brand New Laptops under PR no. 13855**

1. **Metro Iloilo Water District**, through the **Corporate Fund of 2021** intends to apply the sum of **One Million Two Hundred Seventy Thousand Pesos (Php 1,270,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Twenty Eight (28) Units of Brand New Laptops**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. **Metro Iloilo Water District** now invites bids of **Twenty Eight (28) Units of Laptops**. Delivery of the goods is required to **deliver within thirty (30) days upon receipt of P.O. (Purchase Order) or Notice to proceed**. Bidders should have completed, within **2 years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
  - (i) Bidding is restricted to Filipino citizens/sole proprietorship, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from **Metro Iloilo Water District** and inspect the Bidding Documents at the address given below during office hours ( 8:00 a.m. to 5:00 p.m.)
5. A complete set of Bidding Documents may be acquired by interested Bidders on **May 4, 2021 for the downloadable (if bidder opts to obtain it online) and printed version at the MIWD office, Bonifacio drive Iloilo City and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 5,000.00**

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPs) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
6. The **Metro Iloilo Water District** will hold a Pre-Bid Conference on **May 12, 2021, 2:00 P.M.** at the **BAC Office of MIWD, located at the rooftop**, which shall be open to

prospective bidders either in person or virtually (zoom link is posted below or using messenger, but please contact BAC secretariat if opted to attend thru the latter.)

7. Bids must be duly received by the BAC Secretariat at the address below on or before **9:45 A.M of May 24, 2021**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **May 24, 2021**, as well at **10:00 A.M.** at *the BAC Office of MIWD, located at the BAC Office*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below (preferably virtual meeting only due to the pandemic. Link will be posted and and only be provided to bidders who officially purchased the bid documents). Late bids shall not be accepted.

8. Interested bidders may obtain further information from the **BAC Secretariat c/o Mr. Norman Nicolas C. Sanares at the MIWD Office, Bonifacio Drive, Iloilo City** from **8:00 a.m. to 5:00 p.m.** only, **Mondays to Fridays starting May 4, 2021 at Tel. No. (033) 337-3272 local (316)**. However, any query relative to the contents of the bidding documents and the project requirements can only be made by bidders who purchased the bid documents **not later than Ten (10) days prior to the Submission and Bid Opening**.
9. The **Metro Iloilo Water District** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.


